MINUTES

CALL MEETING TO ORDER: Secor called the meeting to order at 6:02 pm.

ROLL CALL: Martin, Everhart, and Secor present. Hillyard by phone. Mayor Canody absent.

III. ENGINEER'S REPORT

A. LAND APPLICATION REPORT-WASTEWATER TREATMENT SYSTEM **ACTION ITEM Infiltration Gallery**-IDEQ has approved plans. Casey is waiting to hear if USDA grant has been approved, because electrical engineer will have to be brought in to do the design. Once funding is acquired, the approval process will be expedited.

Sand Filtration Replacement-Cascade has completed the work and has processed the application for payment. Water needs to be filtered to waste and bacteriologically tested before it can be put into service. **Water Plant Project**-Tonka has delivered the pilot plant report. They are reviewing the delivery schedule and will expedite the submittal process to begin production quicker. TO Engineers has made it clear that system should be operational by summer. The biggest lead time appears to be the shipping container in which the equipment is housed. Final equipment contract should be signed by City at next council meeting.

Letter of Interest-LOI document has been prepared for review and Tom Secor signed.

Land Application Report-TO Engineers will submit. Everhart made motion to authorize TO Engineers to prepare the Land Application Report for the Wastewater Treatment System for DEQ, seconded by Martin. 4 ayes
