1. JACK PINE ROUND-UP BOARD UPDATE AND REQUESTS ACTION ITEM

Dan Myer has been working with the Jack Pine Round-Up Board on land patenting and other improvements with the rodeo grounds along with the other parks associated with the BLM land. Mayor Canody had talked with Amy Bannon from BLM, Four Rivers Office, and was informed of all the surveys that would need to take place before the property could be transferred and wanted to know if the grants would cover these, the city would not be able to bear the burden for the cost. There seemed to be conflicting information and more research would need to be done to figure out the actual cost and who would be covering the costs. There needs to be a city representee in order to get the official documents handed over. Carmen Stanher-Barney, JPRU board Secretary, is asking for letters of support would help with the communication process and allow them to move along without city's direct involvement. The mayor stressed the point of the city not having any extra money in the budget for this project, he was assured there would not be any cost to the city at this time and will be done with grants and no monetary requests at this time.

The mayor has asked if the city Parks and Recreation has been informed or involved. Jacki Bridwell assured the proper channels will be taken to involve the city Park and Rec. John Roberts has been doing some research on past agreements and proposals.
