REGULAR CITY COUNCIL MEETING WEDNESDAY, JANUARY 24, 2018 6:00 P.M. CITY HALL

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:00pm

ROLL CALL: Martin, Everhart, Hillyard present. Secor absent.

PLEDGE OF ALLEGIANCE: Hillyard led the pledge of allegiance.

APPROVAL OF MINUTES: Hillyard made the motion to approve the minutes dated January 10, 2018, seconded by

Martin. 2 ayes. Everhart abstained.

BUSINESS LICENSE APPROVAL

I. ENGINEER'S REPORT

Kasey Ketterling for TO Engineers sent the council his updates via email and it reported the PER to DEQ and a pilot study protocol is in the process of being developed. They are currently waiting for feedback from a couple companies.

The Slow Sand Filter Agreement has been signed by Cascade Enterprises. Kick off meeting for the project is planned for January 29 at 1:00. The project construction will start February 7, 2018.

USDA comments have been addressed concerning the Wastewater Facility Plan and the document has been sent to USDA and DEO.

The Annual reuse permit report is due to DEQ by January 31st for the 2017 reporting year. A one month extension has been granted by Valerie Greear at DEQ.

Everhart is going to talk to Rural Water about a contract operator for wastewater.

A workshop was held on January 23, 2018 to discuss the Transportation master plan. The City is going to wait until they receive word from LHTAC on funding before proceeding with a public involvement process to look at road design options.

Council made the decision not to refund and asks the clerk to send him a letter stating this. Clerk Ling will be working on an ordinance for rules and regulations for the cemetery and a new fee resolution. She will forward to the city attorney for him to look over before presenting to the council.

VI. EMPLOYEE UPDATES

A. PUBLIC WORKS

Tami Franklin has asked for the council's permission to clear out the water storage shed that has old and outdated items and get ready for new equipment. Council agrees and suggests recycling as much as possible before taking to the dump. Council made the decision to not allow anymore repairs in excess of \$600.00 and try to limp it along until spring. Council made the decision to have Secor look into the purchase or lease of a newer one. Dick Linville will send an email to Secor. Everhart is working with IDRW and DEQ on the sampling for water and finding the right reports for monitoring. Tami said she will work Analytical to get the right reports.

Public works is working on getting 2 sand bays done in the next two weeks to be ready for February 7th. Sand Bays

Clerk Ling added a quick thank you to Morgan Franklin for the cleaning job she has been doing until the city can hire a regular employee. The council all made comments on how nice everything has looked and smelled.
