MINUTES

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:00 pm.

ROLL CALL: Hillyard, Secor, Martin, and Everhart present.

PLEDGE OF ALLEGIANCE: Mayor Canody led the Pledge of Allegiance

CONSENT AGENDA

C. CLERK/TREASURER'S OFFICE

1.SOFTWARE UPDATE

Clerk Ptak gave the council an update on the Black Mountain Software conversion. 2.WATER AND SEWER ACCOUNTS

Clerk Ptak had ran across a few issues on water and sewer accounts. Some adjustments are going to need to be made for overbillings. Core and Main sent a quote for upgrades to wands, hand-helds, and touch reads for reading water meters. Training will be in March for Tami, Gene, Nancy and Sue.

3.PAY DOWN VACATION TIME FOR FULL TIME EMPLOYEES ACTION ITEM Clerk Ptak, with the advice of City Attorney Linville, explained the reason for the request for vacation pay down. This is due to the new software conversion and to help clean up the old system. Should be a onetime deal. It is a council decision due to it being a budgetary decision. Clerk Ptak gave the council the figures and how the budget can handle the request. With this being allowed to be done no one will lose their vacation time during the conversion. Vacation will be pro-rated from Dec backwards and going forward it will be pro-rated to January in the new system. It will be added every year at the beginning of the year or hire date from here on out. This will help employees abide by the personnel policy.

Secor made the motion to pay down full time employee's vacation time, a one-time pay down, seconded by Everhart. 4 ayes.

IX. COUNCIL UPDATES

Everhart-AIC; went to city official's day at the Capitol-some new legislation happening, proposal to liquor licenses to allow restaurants to serve maximum 2 mixed drinks with a meal. City approval would be required. Mayor will send legislative updates to the Council members. Everhart stated that sand bay reports have come in. Coliform is running higher coming out than going in and may be due to contaminated sand. Will keep running tests and keep council updated on results.
