CALL MEETING TO ORDER-Mayor Canody called meeting to order at 6:09 pm

PLEDGE OF ALLEGIANCE-Mayor Canody led the pledge of allegiance.

C. CLERK/TREASURER'S OFFICE-

Clerk Ptak updated the council on the new software system. The goal is to have the new system fully up and going March 1st. As of today Utility billing is up and running and will print new bills next week.

x. COUNCIL UPDATES-

Hillyard commented on the way the office is looking and the new computer system and the time Clerk Ptak is putting in to it and thanked her. He has been waiting to see these changes for many years now. Martin thanked Public Works (Tami and Gene) for all their hard work.

XI. MAYOR UPDATES-

Mayor Canody received many good calls about snow the removal. He has asked Deputy Clerk Sue to call the residents on Elk Creek about digging out and marking their mailboxes visible to Public Works as they continue to do snow removal. Next week Mayor Canody, Clerk Ptak, Chief Otter and Public Works Director Franklin will be working on Emergency Management Agreement for the city.

XII. CITIZEN ISSUES-

Scott Johnson - 400 High Street - wants to know if he will have to pay full amount for water hook even though a meter is on the property. Clerk Ptak clarified that it is considered a new hook up since a previous owner had abandoned and withdrew from the system. It is an older meter and would need as much work done as a new one. Sewer would also be needed to be updated and considered as new hook up. Discussion ensued over possibilities of a tiny home or self-contained unit and the city's ordinances.
