# MINUTES

CALL MEETING TO ORDER Mayor Canody called the meeting to order at 6:00 pm.

ROLL CALL Martin, Secor, and Everhart present. Hillyard by phone.

PLEDGE OF ALLEGIANCE Mayor Canody led the Pledge of Allegiance.

# I. CONSENT AGENDA

Martin made a motion to approve the minutes dated March 13, 2019 as written; seconded by Secor, 2 ayes. Everhart and Hillyard abstained.

Wastewater:

RI Bed Lateral Spreading-In contact with DEQ for comments.

Wastewater LOI-DEQ has included IC on the funding list. \$3.7 million at 1.75% over 30 years with \$124,910 principle forgiven immediately. Letter for funding would come late May/early June. City will need to decide if bond election/judicial confirmation to incur the debt at that time. Legal recommends to go for a bond election. (May 2020) Discussion of how to handle.

#### WATER:

Arsenic Treatment: TONKA is revising initial submittal based on DEQ and TO Engineers comments. Discussion of placing equipment and specifications and electrical connection. Infiltration Gallery: USDA will be considering emergency funding. City needs to fill out the documents. Discussion of what comes next.
