# MINUTES

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:00 pm. ROLL CALL: Martin, Everhart, Secor present. Hillyard by phone. PLEDGE OF ALLEGIANCE: Mayor Canody led the Pledge of Allegiance.

# I. CONSENT AGENDA

The consent calendar includes items which require formal Council action, but which are typically routine or not of great controversy. Individual Council members may ask that any specific item be removed from the consent calendar in order that it is discussed in greater detail. Explanatory information is included in the Council agenda packet regarding these items and any contingencies are part of the approval.

# II. PUBLIC HEARINGS

Items listed as public hearings allow citizen comment on the subject matter before the Council. Residents or visitors wishing to comment upon the item before the Council should follow the procedural steps. In order to testify, individuals must sign up in advance, providing sufficient information to allow the Clerk to properly record their testimony in the official record of the City Council. Hearing procedures call for presentation by the applicant, submission of information from City staff, followed by public testimony.

# **III. ENGINEER'S REPORT**

Kasey Ketterling reported for TO Engineers on the Wastewater RI Bed Lateral Spreading. A letter was sent to DEQ on December 12, 2018 that reports on the findings from the RI bed lateral spreading pilot test. Valerie Greear indicated that she should have results back this week. Wastewater Letter of Interest (LOI) is waiting for board approval on wastewater project in May.

The Water Arsenic Treatment, TONKA is making final revisions to their submittal package. They indicated that they are still on schedule to meet the project deadline. TO Engineers is finishing documentation for DEQ approval.

Environmental Information Document – internal review, Preliminary Engineering Report, Brine Disposal – internal review this week, Plans, Specifications, & Estimate – in progress. Electrical – Estimate received from Control Engineers \$15,128, Idaho Power – Waiting for contract with Control Engineers, Infiltration Gallery TO Engineers is compiling documentation necessary to submit to USDA for emergency funding.

Environmental Information Document – internal review Preliminary Engineering Report – internal review RD Apply – to be submitted after State USDA approval of EID and PER.

Discussion of clay bank protection to protect new wells. Possible FEMA grant availability. Possible to use emergency grant money. Discussion.
