Woody talked to Peggy Nance and they approved the expansion for two more ball fields and additional parking. The City's lease was expired, but we're approved to sign a new lease. We will need an amendment to run power and water to the new fields.
- 5) **Funding for P&R Commission** 7:16 P.M.  
The city is currently being paid for use of the rodeo grounds. It's a small fee. The P&R Commission currently does not see that money. Jack Pine Rodeo board believes the fee is too low and that we should raise it. Jack Pine is willing to include the P&R commission in their planning and their work days getting the rodeo grounds ready. They are also willing to help us fund raise and get sponsors. They need help with parking during the rodeo and would let us charge for parking in we supply personnel to park cars. Their next board meeting and work day is on April 21<sup>st</sup> starting at 11:00 A.M.

There has been issues with people taking water from the dump station in large quantities. The city council along with the Parks and Rec board wants to regulate water consumption. We have talked about using cellular trail cameras to record who is taking the water.

TJ Meeks with the BLM has been hard to get ahold of. He was our contact for redoing our lease. Jack Pine gave us a new contact, John Chapburn. Woody will call him and see if he can help us.
