IDAHO CITY REGULAR CITY COUNCIL MEETING WEDNESDAY, MAY 9, 2018 6:00 P.M. CITY HALL

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:01pm.

ROLL CALL: Martin, Everhart, Hillyard and Secor present.

PLEDGE OF ALLEGIANCE: Mayor Canody led the pledge of allegiance.

I. ENGINEER'S REPORT

Kasey Ketterling reported for T O Engineers on the Drinking Water Well Treatment Reverse Osmosis Pilot Study bidding to run for two weeks, Clerk Ling will get it to the Idaho World for publishing; it will be a sealed bid to be opened the 31st of May at City Hall. If all falls into place the pilot testing should be done by the end of June. Kasey will get a bid document together for resanding another bay; the city still has extra sand from the previous resanding.

Everhart is in the process of sampling the first sand bay. DEQ has approved the protocol. Kasey is working with LTHAC to see what the city needs to do to get a better approval rating for the transportation plan. He suggests getting the community involved and letters of support.

Council was in the understanding that they thought Public Works was working on this project.

EMPLOYEE UPDATES

A. PUBLIC WORKS

A letter was provided by Tami Franklin as to the updates for Public Works. The have been working on Dave Selene's fence, the boardwalk, cemetery clean up, the visitors center and numerous spring clean-up.

Pulling sample from treatment plant, trying to work with the county and getting some hot patch for the roads. All the meters have been read. Grader is getting some final touches on it.

Ballfields and rodeo grounds are on; Tami and Gene both have their new phones up and going. Weed spraying will start soon and Gene will work on the street sweeping.

Everhart talked about procedures that need to be in place and implemented for chlorine treatment room, Secor wants it to be a protocol and followed or actions will be taken for termination. They WILL NOT be going into that room alone, always two people. Extremely dangerous to be doing alone. Everhart mentioned a remote scale; it can be checked from outside and replace when needed when there are two available people. Clerk Ling reminded the council of the MSDS folder that should be kept updated. Council agrees there should be one at each shop location and will check to make sure it is updated.

LAW ENFORCEMENT

Chief Otter reported they have been getting busier with t transition into spring/summer, traffic violations, drug offenses and other misdemeanors. He introduced CT Popursky and Bryce Johnson as valuable assets to the force for the city, both have many years and training in various law enforcement areas. Council thanked them for the service and thanked them for coming in and introducing themselves.
