# MINUTES

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:05 pm.

ROLL CALL: Martin, Hillyard, Secor present. Everhart absent.

#### A. ORDINANCE NO. 353 AMENDING TITLE 8 TO SPECIFY THE BUILDING CODES ADOPTED BY THE CITY **ACTION ITEM**

Secor made a motion pursuant to Section 50-902, Idaho Code, the rule requiring that ordinances be read on three different days, two readings of which may be by title only and one reading of which shall be in full shall be dispensed with and that Ordinance No. 353 be considered immediately, seconded by Martin , 3 ayes. Secor made a motion Ordinance No. 353 now before the council be approved, seconded by Martin, 3 ayes.

B. PROPOSED RESOLUTION ADOPTING THE REGION L MULTI HAZARD MITIGATION PLAN Clerk Ling will get an electronic copy of the Region L Multi Hazard Mitigation Plan and send it to the council. Council would like to have more time to go over the information and possibly pass a resolution at the next meeting.

She would like to get a workshop or two set up for the 18/19 FY budget. Council agreed to a budget workshop at 6:30pm 6/19/2018 and a possible second one 6pm 7/17/2018.

Secor would like to see about getting a proposal from Victor Coles as a sewer plant operator and get it on the next agenda.

# X. MAYOR UPDATES

Mayor Canody brought up the situation of Lowell from the Idaho City Fire Protection District parking on Main Street with the larger Engine and asking for donations to be put into the fireman's boot. There is not a problem with it being done, just how it is being done. The traffic getting stopped coming off Highway 21 and backing up Main Street and Highway 21 is not acceptable. The council would like to see the Fire Department put in an Event Checklist for when they want to do this to help maintain safety to traffic and pedestrians. Mitch Tain will get the form from Clerk Ling and will try to get one in anytime there is a big event in town as that is when they try to get the donations from people visiting from out of town.

# XI. CITIZEN ISSUES

This section of the agenda is reserved for citizens wishing to address the Council regarding City-related issues that are not on the agenda. In order to ensure adequate public notice, Idaho Law provides that any item requiring Council action must be placed on the agenda of an upcoming Council meeting, except for emergency circumstances. Comments related to future public hearings should be held for that public hearing. Repeated comments regarding the same or similar topics previously addressed are out of order and will not be allowed. Persons wishing to speak will have 5 minutes. Comments regarding performance by city employees are inappropriate at this time and should be directed to the Mayor, either by subsequent appointment or after tonight's meeting, if time permitting.

Doug Pottenger addressed the council regarding some changes to his propane tank proposal. As soon as he can get the new proposal together he will resubmit his building permit application. Council reminded him about the surveys on his property and the setbacks.

Doug Pottenger also wanted to let the council know of his plans for a property purchase and would like to consider rezoning it in the future.

Mitch Tain addressed the council regarding the event checklist and some parking issues during the parade that he forgot about. Council suggested he contact Chief Otter and help work out the details.
