# MINUTES

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:00.

Everhart asked about late fees being deducted from invoice to TONKA. Kasey spoke to someone who disputed the amount until he explained the hold ups from TONKA, person agreed to the over \$21k deduction. DEQ has requested signed and stamped plans from an Idaho engineer from TONKA. Kasey is waiting for them. She would like to hold another EMT class in the fall. This is a 2-month class including online. She is looking for ideas on how to get the word out and how to remedy the situation. Clerk suggested that information on class can be put on City website. Idaho City needs to reestablish the 501c3 status. It helps with donations of equipment and grants to the Idaho City ambulance.
