MINUTES

CALL MEETING TO ORDER Mayor Canody called to order at 6:00 pm ROLL CALL Hillyard by phone, Secor, Martin, Everhart present. PLEDGE OF ALLEGIANCE Mayor led the Pledge of Allegiance.

In order to testify, individuals must sign up in advance, providing sufficient information to allow the Clerk to properly record their testimony in the official record of the City Council. Hearing procedures call for presentation by the applicant, submission of information from City staff, followed by public testimony.

III. ENGINEER'S REPORT

Mayor Canody and Clerk Ptak spoke to Kristina, Mike and Tim of Mountain Waterworks and were asked about prior approvals at Mores Creek Crossing, more specifically the water and sewer lines. Planning and Zoning is working on a Subdivision and will present to council, they would like some direction from MWW. Task Order only for Mores Creek Crossing, with understanding that Builder will be paying fees. A Special Meeting will be set for next week, Clerk Ptak asked the Council to make notes on the Task Order presented and will get in touch with MWW and ask for someone to be present to discuss the charges with city and Mores Creek Crossing Builder. VI. ORDINANCES AND RESOLUTIONS

Ordinances and resolutions are formal measures considered by the City Council to implement policy which the Council has considered. Resolutions govern internal matters to establish fees and charges pursuant to existing ordinances. Ordinances are laws which govern general public conduct. Certain procedures must be followed in the adoption of both ordinances and resolutions; state law often establishes those requirements.

ORDINANCE NO 360 AMENDING TITLE 8 AND TITLE 10 TO PROVIDE THAT BUILDING PERMITS BE ISSUED BY THE ZONING ADMINISTRATOR ACTION ITEM

Secor made the following motion, I hereby move that pursuant to Section 50-902, Idaho Code, the rule requiring that ordinances be read on three different days, two readings of which may be by title only and one reading of which shall be in full shall be dispensed with and that Ordinance No. 360 be considered immediately. Martin seconded; all ayes. Secor then made the following motion, I hereby move Ordinance No. 360 now before the council be approved; Everhart seconded; all ayes.

2. RESOLUTION NO. 2020-01 RESOLUTION SETTING FEES FOR VARIOUS CITY FEES FOR PERMITS AND USE **ACTION ITEM**

Secor motioned to approve Resolution 2020-02; Martin seconded; all ayes.

VIII. EMPLOYEE UPDATES

A. PUBLIC WORKS

Director Tami Franklin put out a notice for every other day watering because use is very high, fire crews are in town and using water for showers and such, turbidity is coming down, going to break up beaver dams this week on creek. Secor stated that Community Justice will have extra money from skate park grant and has contacted Mr. Electric to put LED lights up at skate park. He doesn't have the details. They don't have the funds for trenching. Secor is donating his time and has asked Tami for help. RV Dump bathrooms are closed because the toilets won't stop running. Secor suggested a fix. Still waiting on parts for the Ford. Secor asked if Tonka has been contacted about broken C-Can. Tami said they have not responded. Attorney Linville will send a letter to them

B. LAW ENFORCEMENT

Chief Mark Otter stated the city has been busy with a one-man crime wave. Seeing more reasons to be in town later and also to be here early in the mornings. Burglaries have been solved and items returned to victims. Martin asked about speeding south of Main. Otter will start working to resolve. Discussion on how to help resolve speeding issues.

C. CLERK/TREASURER'S OFFICE

1. BUDGET PROPOSAL, TENTATIVE BUDGET, RESOLUTION TO BE ADOPTED AT BUDGET HEARING FOR AMOUNT OF FORGONE AND PROPERTY TAXES RESERVED.TO BE RESERVED

Clerk Ptak will email budget proposal and tentative budget to Council by Monday. Resolution has to be done for any reserved tax and forgone amount of money from now on. Clerk presented current (20-21) and last (19-20) budget amounts to council.

2. PUBLIC SAFETY ALLOCATION

\$32K total with \$16,000 for each year, 3 months of this year and 3 months of next year. This is for the Law Enforcement salary expenditures.

3. COVID -19 GRANT ALLOCATION TO BE USED BY DECEMBER 2020

The grant is about \$16,000. Clerk Ptak would like council to come up with ideas on how to spend, must be used by December. Technology has been suggested, iPads have been suggested for Council use.

IX. COUNCIL UPDATES

Secor would like to see an in-house building inspector. Engineered drawings should not have to be presented for a \$500 project or a shop, shed, garage. Secor has suggested someone local come and talk to city on how to become the in-house inspector. Clerk Ptak has talked to DBS about the ongoing issues with the smaller projects and having them only do inspections instead of plan reviews for the smaller projects.

X. MAYOR UPDATES

Mayor Canody held a departmental supervisor meeting and would like to get back to doing these again at least once a month.
