CALL MEETING TO ORDER Mayor Canody called meeting to order at 6:00 pm

I. CITY-ENGINEER CONTRACTS

- ACTION ITEM: TASK ORDER 294-02 EXECUTION

Troy Ashworth was present to represent Mores Creek Crossing. Council asked Troy Ashworth what he paid. T-O previously for the preliminary plat. Mountain Waterworks is reviewing water and sewer capacity for Mores Creek Crossing #2. Discussion will need to be had between City and Builder Ashworth for costs to be covered by whom. Council discussed with Mountain Waterworks, Mike Woodworth, of duplicated review so builder is not double charged. Councilman Secor approved Mountain Waterworks Task Order 294-02; seconded by Martin; 3 ayes.

II. FY 20/21 BUDGET WORKSHOP

Mayor and Clerk had reviewed the budget and presented to Council. Clerk Ptak explained Payroll, Revenues and Expenses for 2020/2021 budget. Budget is very tight this year. State recalculated tax funds and the County has a shortfall. Clerk is waiting to hear what that is going to look like. Public works has the funds this year for a side by side to be used for various projects. Director Franklin is researching.
