REGULAR CITY COUNCIL MEETING WEDNESDAY, SEPTEMBER 13, 2017 6:00 P.M. CITY HALL

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:01pm.

ROLL CALL: Martin, Everhart present, Hillyard by phone. Secor absent.

PLEDGE OF ALLEGIANCE: Mayor Canody led the pledge of allegiance.

AMENDMENT TO AGENDA SHOWN IN **BOLD** LETTERING Idaho Code 67-2343

Everhart made the motion per Idaho Code 67-2343 to make an amendment to the agenda shown in bold lettering in the section of the engineers report to approve partial payment #11 &12 for wastewater facility and allow for mayor's signature, approve partial payment #46 & 47 for city water project and allow for mayor's signature and approve engineering fees for July 2017 and August 2017, seconded by Martin. 3 ayes.

I. ENGINEER'S REPORT

Russ from TO engineers reported on the well project explaining Dave Adamson was performing the camera on the wells and the camera broke. He had to send it back for repair and plans to get it done as soon as possible.

Russ has contacted the electrician to get the tank mixers installed and should be done September 11.

The contractor has provided submittals and has a few left to submit for the Package 3C well water mains. They plan to start September 25th based on their current schedule.

The RI Bed lateral spreading project still needs installation prior to winter.

USDA-RD required an environmental report for the wastewater project along with the Idaho State Historical Preservation Society for reviewing before continuing. It is now being submitted to USDA for approval.

Bailey and Company is asking for the Mayors signature to move forward with the upcoming audit scheduled for November 28th through December 1st. Dick Linville suggests this go on the next agenda for the council's approval for the mayor to sign since it is a large amount of money. She also explained why the water bills were later than usual. The water bills were generated completely on the new system and still had a few glitches; she apologized to the public and council and hopes to have this issue resolved. New various manuals have been ordered for the city pertaining to many areas of city business. She also suggests the council have a workshop for the Fire District Transfer so everyone will have a chance to look at the appraisal and discuss; mayor and council agree.
