MINUTES

CALL MEETING TO ORDER Mayor Canody called meeting to order at 6:00 pm ROLL CALL Hillyard, Secor, Martin and Everhart all present.

A. APPROVAL OF MINUTES: September 9, 2020 and September 16, 2020 Special Meeting **ACTION ITEM**

Councilman Secor made a motion to accept the minutes of September 9, 2020 and September 16, 2020; Councilman Hillyard seconded; Councilman Martin abstained, 3 ayes.

- B. IDAHO CITY EVENT CHECKLIST: Doug Pottenger Idaho City Days **ACTION ITEM**Doug was present and discussed the site map which includes the rodeo grounds along the ATV trail to his parking lot. Chief Otter approves as long as there is traffic control. Hillyard made a motion to approve Mountain Man Challenge on October 4, 2020; Martin seconded; 4 ayes.
- C. BILLS/PAYABLES: September 10, 2020 through September 23, 2020 **ACTION ITEM** Secor made a motion to pay the bills dated September 10, 2020 through September 23, 2020 in the amount of \$20,735.60; Martin seconded; 4 ayes.

Hearing procedures call for presentation by the applicant, submission of information from City staff, followed by public testimony.

A. STEVE ELLIS REZONING

Mr. Ellis has acquired a small lot behind the Gold Mine that he would like rezoned from residential to commercial. He presented a plat to the council that shows how he would like to turn his lot into an RV park that would connect to his current RV park. City Attorney Linville stated it needs to be presented to Planning and Zoning first and they make their recommendation to Council. Clerk Ptak mentioned the next meeting is October 12, 2020. Mayor stated October 12 is a Holiday, so P&Z would need to reschedule. Mr. Ellis mentioned a sewer hookup may need to be extended or a new hook up all together. Most likely a new hookup will be needed after discussion.

Resolutions govern internal matters to establish fees and charges pursuant to existing ordinances. Ordinances are laws which govern general public conduct. IX. EMPLOYEE UPDATES

A. PUBLIC WORKS

Public Works Director Tami Franklin gave her report. Valley Wide Propane approached her stating they are less expensive, Secor said they are not. Rodeo grounds thinning. Skate Park thinned. Someone asked for cottonwood logs and she said yes, but they would have to load. Burn piles are waiting for rain to light. Katherine Mitchell on the corner had a leak that she will need to fix. Tami and Dom gave her names of plumbers. If she doesn't have fixed by the time she leaves for vacation, Tami will turn her water off. She had been working with the clerk's office about her bill and found the leak. Andy and Verline Gulick had their leak fixed. Brent Adamson at the Merc has a leak under the boardwalk and he is fixing it. Meters will be insulated by the read in October. No updates on white pickup getting fixed yet.

B. LAW ENFORCEMENT

Chief Otter will be concentrating on Code Enforcement over the next 2 weeks. He plans to get the decoy vehicle out to slow traffic. He is looking into a speed sign he may be able to get donated.

C. CLERK/TREASURER'S OFFICE

Clerk Ptak reported everything for budget has been sent to the state. She will start closing the year up next week and getting new year ready to open. She and Chief Otter will work on the RV/camp trailer ordinance.

X. COUNCIL UPDATES

Councilman Everhart-crews are starting to work on Mores Creek Crossing Phase 2, cutting roads and such.

XI. MAYOR UPDATES

Governor sent a message out that an Emmett firefighter was killed fighting a fire and American and State flags will fly at half staff to honor him. City elected officials had a meeting with the Governor and Idaho is third in employment recovery. Health Officials and Governor are urging everyone to get a flu shot this year. County is waiting for the Surveyor to send the Deeds for the land swap.

City Attorney Linville suggested P&Z group the land rezoning items together so they can be heard at the same time. Public hearings through P&Z will need to be held for rezoning issues.

XII. CITIZEN COMMENTS
