MINUTES

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:01pm.

Grant Moore from TO Engineers presented the council with a bid from Cascade in the amount of \$48,940.00 to re-sand Bay #3. Council agrees to have a Special Meeting next Monday to approve Cascade's bid. TO will move forward with Cascade. Lab tests are coming in for the pilot testing for the RO and the numbers are coming in good. TO is working on the numbers for operations. USDA is looking at the funding application and informed the funds if granted will not be available until November.
