CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:00pm.

ROLL CALL: Secor, Everhart and Martin present. Hillyard absent.

PLEDGE OF ALLEGIANCE: Mayor Canody led the pledge of allegiance.

 - 1. ALLOW MAYOR SIGNATURE ON PAY REQUEST NO 10 AND 11 FOR WIN GRANT S658-00 **ACTION ITEM**

Secor made a motion to allow the mayor to sign pay request 10 and 11 for WIIN Grant S658-00, seconded by Martin. 3 ayes.

2. WATER LEAK AT 113 E HILL ROAD BILL FORGIVENESS – TRUDY JACKSON **ACTION ITEM**

A discussion was had regarding future leaks and billing procedures. The council discussed the possibility of having a minimum amount before the ability to ask for forgiveness, they also discussed the policy of the clerk's office on the smaller leaks, the possibility of showing proof of leak and fixing the leak. Concern about homeowners turning on and off the meters themselves, this should not be happening. The meters are expensive and should only be turned off and on by public works, this has been an ongoing issue and needs to be addressed. Attorney Joan Callahan suggested the council set some standards from here forward what the council would like to see happen and act on those. As of right now the precedence has been set that the city will forgive 50 percent on water leaks if asked. Secor made a motion to reduce the current water usage billing for a

water leak at 113 E Hill Road for Trudy Jackson, in the amount of \$45.53, half of the billed amount during the leak, and was seconded by Martin. 3 ayes.

3. COMMUNICABLE DISEASE POLICY ACTION ITEM

Council had questions regarding the authority and actions that can and cannot be taken during a breakout of any disease. The policy came from ICRMP. The state will always supersede the city in an emergency declaration. It really does not change the chain of command, supervisors will still make the determination unless otherwise notified, the policy should have a cleaner clarification on the chain of command. Council would like to see some changes and brought back to them. The personnel policy will also need to be updated, Clerk Ptak will look at ICRMP's newest edition and let city attorney look it over.

4. PERMANENT CAMPING RESTRICTIONS ORDINANCE REVIEW

This will go back for further review and some of the items will need to go before planning and zoning. Chief Otter would like to get this up and going soon, due to weather and the influx of people trying to come up and live during the winter months. Health and Safety are the main concern. In the past years anything had been allowed, with new owners of the RV parks having been working towards cleaning up and maintaining a certain level of standards, Chief feels this is the perfect time to get this going. Council is divided on how this should be handled; it will go back for further review. All agree, long-term rental living is what is needed. More public input needs to happen, whether it does is up to them, meetings have been posted, public hearings will have to happen before any changes regarding planning and zoning. Ashley Elliott and City Attorney both suggested to see what other cities are doing since this is an ongoing issue with many other cities. Ask the state about what their requirements or suggestions might be. Council will come up with their thoughts and concerns, adjustments they would like to have and get this back on the next agenda. The last update was in 1958 on trailers, needs updated.

IX. EMPLOYEE UPDATES

A. PUBLIC WORKS

Public works director Tami Claus updated the council regarding the RO system, they need to be purged further and sand samples, some testing still. Cascade will come up next week and finish up, concrete will get poured, sand will be delivered. She is worried about the sewer plant road getting fenced off by the current landowner, Tami does not want to fight the landowner. Mayor said the city has an easement and the city should still be able to access this area.

B. LAW ENFORCEMENT

Chief otter has been doing more traffic control, working on getting a solar batterie for speed sign, computers are up and going, ITD grants are getting worked on. Full time officer will be starting in November.

C. CLERK/TREASURER'S OFFICE

Clerk Ptak updated the council on year end budget query, still needs a few adjustments but for the most part last year's budget looks to be in good standing. Road and Street report will be published in the next paper. She informed the council that there has been some inquiry in having yurts in the city limits, this will go to planning and zoning. She informed the council she would be working remotely for the next few weeks due to a family situation, but she will be just as available as ever. She asked if someone from the council could help in setting up for the zoom meeting for the next council meeting, she will be attending it by zoom.

Martin asked if the city would be interested in Life Flight for city employees. Clerk Ptak will look into this after getting more information from Martin.

Everhart gave some AIC legislative updates. Many things getting worked on including cyber security, clerk Ptak also gave an update regarding new email domain getting put into place to help with this area of concern. Secor had none at this time.

XI. MAYOR UPDATES

Mayor Canody will help get the meeting up and going while Clerk Ptak is out of town for the next meeting. He asked if Chief Otter would do a ride around town with Public Works Director Tami Claus and see what signs need to be added or replaced before winter, such as no parking signs between Main and Montgomery on Elk Creek.
