CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:05 pm. ROLL CALL: Hillyard and Martin present. Everhart by phone. Secor absent.

Clerk Ptak stated the chamber has sent out an email asking for feedback on how Idaho City Days did for the community. The city had received the vendor permit fees and has paid for the port a potties for that event.

IX. EMPLOYEE UPDATES

A. PUBLIC WORKS

Public Works director Tami Franklin was not present as she felt it was against her rights to be made to wear a mask to the meeting. Council Martin felt she should have been here. Hillyard agrees with the safety concern, but unhappy as to how this came about to enforce the mask mandate. Mayor Canody explained that after the Governor putting the State back into Stage three, he felt it necessary to enact. Councilman Hillyard wanted to know why it was not brought to the council after the previous meeting they did not approve the mask mandate. The mayor explained this was after that particular meeting and felt it necessary to move forward after consulting with the city attorney. There were also employees who supported the mask requirement for their own safety and that of the others. The mayor pointed out it is the responsibility of the city to provide a safe environment for all employees. Hillyard was disappointed the council was not notified first. Martin also agreed they council should have been notified. Everhart explained this was the reason he was not physically present at the meeting and did not feel the mask mandate was the right decision at this time. More discussion concerning the mayor's actions and the council's opinion. Attorney Linville explained to the council that the mayor had the right to issue the mask requirement but the council also had the right to rescind the mayor's decision. Council would like to have a special meeting to consider requiring masks at city hall during business hours and public meetings. A meeting was set for November 4th 2020 at 6pm at city hall.

The mayor finished with the public works updates, meters are winter ready, cleaning sand bay next week, getting everything winter ready. Waiting to hear from ITD about the speed count on the highway.

Clerk Ptak felt having the regular meeting would be too early in the month to make it beneficial for bill paying, the council will reschedule the regular meeting during the special meeting.

No further updates from Everhart and Hillyard. Martin gave update on Fish and Game. Hillyard asked when the RV dump will be shutting down, it was explained it will be shut after hunting season. He asked if something can be done with the donation box to make it more visible.
