MINUTES

CALL MEETING TO ORDER: Mayor Canody called the meeting order at 6:00pm.

ROLL CALL: Martin, Everhart, Secor present. Hillyard absent.

II. PUBLIC HEARINGS

Items listed as public hearings allow citizen comment on the subject matter before the Council. Residents or visitors wishing to comment upon the item before the Council should follow the procedural steps. In order to testify, individuals must sign up in advance, providing sufficient information to allow the Clerk to properly record their testimony in the official record of the City Council. Hearing procedures call for presentation by the applicant, submission of information from City staff, followed by public testimony.

III. ENGINEER'S REPORT

Kasey Ketterling from TO Engineers reported on...

Water plant bids were \$240,000 last year, new bids were \$630,000 and more. Companies are not willing to come up to Idaho City without a higher bid. City will do underground at new water plant and have electrical bid out in the spring. City will address the water project in Spring 2020 and once its addressed will move forward with the sewer project. City may address the voters for a sewer bond after water is completed. Kasey will talk to DEQ and let them know that City has chosen Option 2.

IV. OLD BUSINESS

A. NEPTUNE 360 PURCHASE OF DATA TRANSFER ACTION ITEM

Clerk presented that the transfer is \$200 through Black Mountain Software. Hardware has been ordered. No motion needed for software transfer. Council approved cost.

B. 2019/2020 EMPLOYEE 5% RAISE ACTION ITEM

Council needs to make a formal motion to approve the 5% budgeted raise for the employees. Secor made a motion to approve the 5% employee raise for the 2019/2020 budget year; seconded by Everhart. 3 ayes.

VI. ORDINANCES AND RESOLUTIONS

Ordinances and resolutions are formal measures considered by the City Council to implement policy which the Council has considered. Resolutions govern internal matters to establish fees and charges pursuant to existing ordinances. Ordinances are laws which govern general public conduct. Certain procedures must be followed in the adoption of both ordinances and resolutions; state law often establishes those requirements.
