MINUTES

CALL MEETING TO ORDER: Mayor Canody called the meeting to order at 6:00 pm

ROLL CALL: Martin, Secor present. Hillyard by phone. Everhart absent. PLEDGE OF ALLEGIANCE: Hillyard led the pledge of allegiance.

I. CONSENT AGENDA

The consent calendar includes items which require formal Council action, but which are typically routine or not of great controversy. Individual Council members may ask that any specific item be removed from the consent calendar in order that it is discussed in greater detail. Explanatory information is included in the Council agenda packet regarding these items and any contingencies are part of the approval.

A. APPROVAL OF MINUTES: OCTOBER 24, 2018 AND NOVEMBER 14, 2018 **ACTION ITEM** Secor made a motion to approve the minutes dated October 24, 2018 and November 14, 2018, seconded by Martin. 3 ayes.

B. BUSINESS LICENSE APPROVAL: ACTION ITEM

Clerk Ptak explains other city's way of licensing requirements approval; usually clerk and mayor approve and update Council. Idaho City requires Council to approve all licenses at regular or special meetings. Clerk Ptak would like an Ordinance to change the process for approving business licenses. City attorney present to advise. Discussion as to why Idaho City has an ordinance. Attorney advises that current ordinance states that Clerk can issue tentative license and bring to next regular council meeting. Attorney Linville will draft a new ordinance to change way of issuing business licenses and bring to Council.

D. IDAHO CITY CHAMBER OF COMMERCE

1. CHILI COOK OFF LOCATION CHANGE ACTION ITEM

Rhonda Jameson presented the council with thoughts on and plans on moving the Annual Chili Cook-Off to Main Street instead of the Visitors Center parking lot. Discussion ensued. Council suggested closing Main from Walulla to the Visitor Center.

2. CHRISTMAS LIGHTS AND DECORATIONS

Chamber is no longer doing this event. BBIA is doing it. The City was asked to possibly help with lighting the stamp mill. They would like the City to take the lead on checking the tree and decorations and starting the install around Thanksgiving. The council feels the one in charge of the function (BBIA) should be the one asking the City for the help, not the Chamber.
