## <u>IDAHO CITY FIRE PROTECTION DISTRICT BURNING PERMIT</u> **WITHIN CITY LIMITS**

CONDITIONS OF PERMIT: SUBJECT TO AIR POLLUTION CONTROL
<b>IDAHO CITY ORDINANCE #274 PROVIDES:</b> No person shall allow, cause or permit the burning of materials which emit toxic contaminants or large volumes of smoke, particulates or odors. These materials include garbage, rubber, plastics, heavy petroleum products, dead animals, lumber, tree stumps, trash, etc.
BURN BARRELS ARE PERMITTED FOR PAPER PRODUCTS ONLY – NO TRASH! BARRELS MUST HAVE A 1/4" MESH SCREEN COVERING THE BARREL.
OPEN BURNING OF PILED LAWN YARD OR DEBRIS.
PERMIT ISSUED FOR DATES
PERMITTED BURN HOURS ARE EARLY A.M. OR LATE AFTERNOON ONLY!
~ PERMITTEE OR COMPETENT REPRESENTATIVE SHALL BE IN
CONSTANT ATTENDANCE UNTIL ALL FIRE IS EXTINGUISHED.
~ DO NOT BURN IF CONDITIONS ARE WINDY!
~ HAVE GARDEN HOSE AND SHOVEL READY TO USE. ~ CALL BOISE COUNTY SHERIFF'S OFFICE PRIOR TO BURNING: 208-392-4411
~ CALL BUISE COUNTY SHERIFF S OFFICE PRIOR TO BURNING: 208-392-4411
